

## Baxi 'Keep Heating Britain' Prize Draw Terms and Conditions

- 1. The promoter is Baxi Heating UK Limited (company number 03879156) ("Baxi"), whose registered office is at Brooks House, Coventry Road, Warwick, CV34 4LL.
- 2. The promotion is open to Baxi Works members within the United Kingdom aged 18 or over. Employees of Baxi, their families, agencies, or anyone else professionally connected with the promotion are not eligible to participate.
- 3. By entering the promotion, participants will be deemed to have accepted these terms and conditions and agreed to be bound by them.
- 4. The promotion will run from 00:01 hours on Monday 25<sup>th</sup> January 2021 to 23:59 hours on Sunday 4<sup>th</sup> April 2021 inclusive (the "promotional period").
- 5. To qualify for the promotion, participants must either:
  - a. join Baxi Works during the promotional period and register at least one Baxi boiler (excluding the Baxi Assure range) for warranty only or both warranty and Gas Safe on Baxi Works during the promotional period. Any Baxi boiler not registered for warranty only or warranty and Gas Safe during the promotional period will not qualify for the promotion, regardless of installation date, technical issues or installation problems. Each correctly completed registration will qualify as an entry to the promotion. There is no limit on the number of registrations a participant may make;
  - b. have joined Baxi Works prior to the promotional period and submit a testimonial explaining how Baxi Works has helped them. Testimonials must be at least 25 words in length and can only be submitted through the participant's Baxi Works account using the suggestion box feature. Only one correctly submitted testimonial per Baxi Works account will qualify as an entry to the promotion. In the event that multiple testimonials are received, only the first will be accepted.



6. Valid entries received will be entered into a weekly prize draw. It is anticipated that the draws will take place every Wednesday during the promotional period, with the first draw being held on 3<sup>rd</sup> February 2021 and the final draw on 7<sup>th</sup> April 2021, however Baxi reserves the right to hold a draw on an alternative day should such need arise. Valid entries received between 00:01 hours on Monday to 23.59 hours on Sunday will be entered into the draw on the subsequent Wednesday.

- 8. Winners will be contacted by 8848, our telemarketing provider, within five working days of the weekly prize draw for confirmation of their name and delivery address. Once confirmation is received, prizes will be despatched to the winners within seven working days. Baxi accepts no liability for any losses resulting from the provision of incorrect contact or address details by participants.

In addition to the weekly prize draws, all valid entries received will be entered into a separate prize draw to win a Nissan e-NV200 Visia Electric Van 24 month lease and standard installation of a Pod Point home electric wall charger ("the lease prize draw"). The lease prize draw will take place on Friday 9th April 2021 with the winner being selected at random. The winner will be contacted within five working days of the lease prize draw.
